1) \_\_\_\_\_ I understand that set up is available on 15 October after 12:00pm. If we choose not to set up on the 15th, I agree that all set up of my booth must be **completed** NO LATER THAN 3:00pm on 16 October 2019.

2) \_\_\_\_\_ I agree that all sample fees will be at my discretion in the amounts of \$3-\$5 per Sample. All Samples must be paid in tickets. **NO CASH SALES.**

- 3)\_\_\_\_\_ I understand that ALL tickets must be turned in to EVENT STAFF each night prior to leaving The Taste of Cave Creek. I understand that the tickets will be placed in a sealed, see through envelope provided by event staff each evening.
- 4) \_\_\_\_\_ I acknowledge that in exchange for participating at The Taste of Cave Creek, I will be reimbursed \$.75 for every ticket submitted to my restaurant at The Taste of Cave Creek.
- 5)\_\_\_\_\_ I understand that I am responsible for any spills which occur on the property of Stage Coach Village and agree to clean up any such spills, and notify event staff of any such spills.
- 6)\_\_\_\_\_ I understand that ALL restaurants must obtain **REQUIRED PERMITS** from Maricopa County in reference to catering and food handling.
- 7)\_\_\_\_\_ I acknowledge that Maricopa County will be inspecting my restaurant booth, and that I will be responsible for compliance with Maricopa County Department of Health Regulations.
- 8)\_\_\_\_\_ I understand that I am **NOT** allowed to take any cash in lieu of tickets at The Taste of Cave Creek, for product samples.
- 9)\_\_\_\_\_ I understand that as long as I submit my tickets each evening to event staff, that I will be reimbursed for my ticket sales within **35 DAYS** after completion of the event.
- 10)\_\_\_\_\_ I understand that I must provide ALL requirements for electrical power needed for my booth NO LATER than 15 September 2019 to Marshal Stein.
- 11)\_\_\_\_\_ I acknowledge that The Taste of Cave Creek will provide a tent / pop up for my restaurant at The Taste of Cave Creek. I acknowledge that I am responsible for any damage to the provided tent / pop up.
- 12)\_\_\_\_\_ I agree to provide a fire extinguisher for my restaurant booth.
- 13)\_\_\_\_\_ I agree to provide the menu items that I intend to offer at The Taste of Cave Creek NO LATER THAN 25 August 2019, to Marshal Stein.
- 14)\_\_\_\_\_ I understand that only the agreed upon restaurants which will be hosting event sponsored bars, will receive compensation for hosting the bars at the event.

15) \_\_\_\_\_ I agree to maintain my booth and staff my booth until 9:00 pm each evening of the event and I agree that I will not be permitted to leave the event prior to 9:00 pm each evening.

16) \_\_\_\_\_ I agree to allow photos of my staff and booth to be utilized by the Town of Cave Creek for promotional activities associated with the Town of Cave Creek.

17) \_\_\_\_\_ I understand that I am responsible to provide all items I will need to have at the Taste of Cave Creek, including all paper goods!

18). \_\_\_\_\_ No restaurants are allowed to serve any alcohol. Any restaurant found to be offering or serving alcohol other than agreed upon Taste of Cave Creek Bars will be subject to forfeit all ticket sales and asked to leave the event.
